Dr. Scotty Bolding is the Chairman and CEO of [US Health Record Incorporated](#). He is one of the original cofounders of the company and has been working for over 15 years developing health information technologies to enhance patient care. He and cofounder Dr. Richard Roblee are the coauthors of the textbook "Interdisciplinary Dentofacial Therapy" published in 1994 emphasizing that high quality healthcare requires a centralized health record model that is shared by the patient's healthcare providers. In 1995, they began developing a web-based electronic personal health record that houses all of the patient's medical and dental information. The system has all of the security controls to allow for record sharing, and embedded electronic medical record tools and interfaces to assist the health care providers in populating the record. The company has continued to develop the system with the latest technologies and now the platform has been recognized as one of the leading solutions for the future of healthcare on the market today. Their development team recently received the Microsoft Healthcare Partner of the Year Public Sector Award for 2009 for the work on their platform design.
